

Ripley County Commissioners Meeting

April 04, 2022

Pledge of Allegiance

Roll Call

Present: Mark Horstman, President, Chris Schmaltz, Kendall Hankins, Amy Copeland, Auditor & John Ertel, County Attorney.

Public Comment

A gentleman was in to ask about a court claim for \$2,500.00. The claim is for Frank Aaron Negangard. He is a member of our pauper counsel.

Maintenance – Craig Herbert

Mr. Herbert stated that GenSet came out and did maintenance on the generators. The EMS generator at Milan has water in the oil. Mr. Herbert is getting quotes to get this fixed.

The water pump is out on the generator in the annex. The quote on a new water pump is \$1,615.78. Commissioners stated to pay this out of Edit building repairs.

Motion: Commissioner Schmaltz made the motion to approve to pay the \$1,615.78 out of Edit, Building Repairs. **Action:** Approve, **Moved by** Chris Schmaltz, **Seconded by** Kendall Hankins. Motion passed unanimously.

Mr. Herbert stated he was with the state fire inspector on April 04, 2022 and so far everything has went good.

Highway – Ray Toops

Mr. Toops stated that he stills does not know if they received the Community Crossing Matching Grant.

Mr. Toops stated they have been interviewing for a new truck driver. He is wanting to hire Neal Wilson. He can start 2 weeks from today. The Commissioners gave their blessing on this.

Mr. Toops stated that 421 is now closed from Osgood to Napoleon. Commissioner Schmaltz stated he had a call about 700 North and Michigan Road being very dangerous.

Mr. Toops stated that Mr. Huntington talked to him about Six Pine Ranch Road. This is on Small Seed Company, LLC property. Attorney, John Ertel, stated to get all of the information to him and he will get a letter written to him.

Mr. Toops stated he met with Holly Wehr and talked about the signs for the bike trail at the Versailles State Park. This is on 25 South. Ms. Wehr talked about where the signs would be placed.

Commissioner Horstman stated that a gentleman by the name of Duane Swingle called and wanted to know when his gravel road would be paved. This is not known at this time.

Commissioner Hankins stated that we can receive up to \$40,000.00 for the 200 South damage. The garage has used \$10,000.00 to \$11,000.00. They are going to pave 200 South with the remainder of the money.

Commissioner Hankins asked if the inventory count was done yet and Mr. Toops stated they would try and have that done by the next meeting.

Sheriff – Kurt Enneking

Mr. Enneking stated that Finks Road has had a lot of complaints about more traffic. Michigan Road will also be patrolled more than usual due to 421 road closure. They will be patrolling more than average.

EMS – Scott Huffman

Mr. Huffman brought in a letter from workers compensation about an adjustment of claim filed.

Commissioner Schmaltz asked if Dearborn County was taken care of the problem with EMS coverage. Mr. Huffman stated they have taken care of it.

The two bids are from Performance Services and Veregy.

Public – Bob Steele

Mr. Steele was in to talk to the Commissioners about building 100 dams from Batesville to Friendship. These would be made out of Ripley County lime stone.

Building Inspector – Dwight Bauman

Mr. Bauman was in about his work truck being fixed and worked on. Mr. Bauman states the truck is rusting on the fender well. Mechanically the truck is working fine. Commissioner Horstman stated the cosmetics are not trouble for him but to ask for the money for the capital asset at budget time. Mr. Bauman just wanted to bring the matter to the Commissioners attention.


