

# Ripley County Commissioners Meeting

## August 21, 2023

### Pledge of Allegiance

### Roll Call

**Present:** Mark Horstman, President Kendall Hankins, Chris Schmaltz, Amy Copeland, Auditor & John Ertel, County Attorney.

### Maintenance – Craig Herbert

Mr. Herbert stated that there was a roof leak in the annex building, and it has been fixed.

Mr. Herbert orders chemicals from Atom Chemicals for the annex and the courthouse.

Mr. Herbert stated that Johannigman Excavating will be calling with a bid for parking on the North side of the courthouse.

Mr. Herbert brought in the GenSet bid for the generator for the 911 towers. The bid is \$7,690.96. J & L Electrics bid was for \$8,360.00. The Commissioners gave the approval for the GenSet bid.

### Jeff French – Surveyor

Mr. French came in wanting to know how they wanted to take care of the van that they have that was replaced with a new pickup. The Commissioners told him to put it on the auction.

Commissioners discussed the Next Level Connections Grant. The Commissioners are to decide which addresses are in need to have broadband. Commissioner Horstman is going to call to get the NLC 4 listing from area broadband companies. This information needs to be done by September 15, 2023.

### Highway – Jason Edwards

Mr. Edwards stated he talked to Mike in Ohio County about the Mr. Huntington fence incident. Ohio County stated that Mr. Huntington can get ahold of them if he feels he needs too.

Mr. Edwards asked if there was a line of sight ordinance. The Commissioners stated that they are not aware of one.

Mr. Edwards stated that they hired a new secretary and she will start on August 28, 2023.

Mr. Edwards stated that the highway garage office floors started to be replaced today.

Mr. Edwards stated that the truck rodeo at the highway garage will be on Thursday.

Mr. Edwards met with USI about Cave Hill Road. It will be a 9 million dollar bridge.

Commissioner Hankins asked if it would be sufficient if 2 mowers ran together. Mr. Edwards stated he would try it.

### Sheriff – Rob Bradley

Mr. Bradley stated that he doesn't really have anything.

Mr. Bradley stated that he is not very happy about how the raises went.

Commissioner Hankins asked the sheriff about parking probation vehicles at the Jail. He stated that the probation could do so.

Ms. Cairns asked the Commissioners about the auction and how to handle the cars.


