## **BONDS ON BODY ATTACHMENT**

NO ADMIN FEE IS ADDED UNLESS IT IS STATED ON THE BODY ATT. + ADMIN FEE. THE AMOUNT SET BY THE JUDGE IS THE BOND AMOUNT.

### **BONDS ON WARRANTS**

THERE IS ALWAYS AN ADMIN FEE (OF \$55) ADDED ON WARRANTS

# IF THERE IS NO BOND AMOUNT STATED ON WARRANT

BOND CAN BE DOUBLED (FOR PENDING CHARGES OR ON PROBATION.)

IN THE FORM OF A POSTAL MONEY ORDER (FROM A POST OFFICE)
IN THE FORM OF A CASHIERS CHECK (FROM A LOCAL BANK)
AT THE CLERKS OFFICE DURING BUSINESS HOURS OF 8AM TO 4PM MONDAY-FRIDAY
WITH A CREDIT CARD USING ALLPAID 24/7. CODE #7922, MUST HAVE LAST 4 OF SS#
NO BONDS WILL BE PAID DURING INMATE MEAL TIMES

# **BOND FOR NEW CHARGES**

DOUBLES IF INMATE HAS PENDING CHARGES OR IS ON PROBATION

# AN INMATE CAN BOND THEMSELVES OUT

IF THEY HAVE THE EXACT AMOUNT IN CASH ON THEM AT THE TIME OF BOOK IN.
