Pledge of Allegiance

Roll Call

Present: Commissioners Mark Horstman, Roger Gullion, Jeff Volz, John Ertel, Attorney, Amy Copeland, Auditor.

Commissioner Horstman stated when the Attorney gets here that he would like to make June small business month. He would like the attorney to draw up a proclamation.

Maintenance - Craig Herbert

Commissioner Volz stated that the landscaping rock for the courthouse is not being made anymore. The Commissioners would like to match the Courthouse and the Annex.

Mr. Herbert got a quote from TK elevator for \$16,530.92 to replace a valve in the elevator.

Mr. Herbert stated that office shop gave a quote for book shelves for the Superior Court, the quote is for \$5,572.00. The Commissioners stated that they wanted to pass on the quote for now.

The Office shop also sent a book with the colors they could pick out for the signage at the courthouse.

Mr. Taylor wants to ask for a special session to talk about some findings they found when they bid the county Insurance. Assured Partners did pull their bid for the 2025-2026 bid for insurance.

Probation – Shannon Schmaltz

The Commissioners and the Auditor left the meeting room to go to the Courthouse renovation project.

The Commissioners talked to Probation Director Shannon Schmaltz about his chairs and desk that were destroyed in the construction process. The Commissioners told Mr. Schmaltz they would pay for new chairs. He did not ask for the Commissioners to pay for the desk.

The Commissioners talked to Child Support, Amanda Brunner, about where they keep their confidential files. The room needs a ceiling fan in it to move air, so it doesn't get musty in the room. The Commissioners are going to put up a ceiling fan. The Commissioners also told her it was ok to hang the Indiana child support seal and to hang a bulletin board.

The Commissioners discussed the bathrooms in the basement. The job done in the basement was not done correctly and was done very messy. Veregy and the Commissioners agreed they are going to have to redo the bathrooms in the basement of the Courthouse. Veregy stated they would take care of the matter.

The Commissioners also talked with Total Tech and all cameras that were in the Courthouse when the project started will now be network cameras with Total Tech.
