# Pledge of Allegiance

#### Roll Call

**Present:** Commissioner Roger Gullion, Commissioner Jeff Volz, Attorney, John Ertel, Auditor, Amy Copeland. Commissioner Mark Horstman was absent.

#### 911 - Will Sunderman

Mr. Sunderman is asking for an additional 4 days of Bereavement.
