Pledge of Allegiance

Roll Call

Present: Mark Horstman, President, Kendall Hankins, Chris Schmaltz, Amy Copeland, Auditor & John Ertel, County Attorney.

Maintenance - Craig Herbert

Mr. Herbert brought in two quotes for 911 for glass mats, Office Shop \$687.00 & Vitrazza \$2,985.00. The Commissioners stated to go with Office Shop.

Mr. Herbert talked about AEDs for the buildings in the county. Mr. Scott Huffman from EMS was in to talk about having a Zoll representative. Mr. Huffman stated that he will be liable for checking the AEDs in the county. Mr. Huffman is going to take the lead on the AEDs and ordering from Zoll.

Area Planning - Tad Brinson

Mr. Brinson was in and stated that Ms. Jennifer Miller resigned from Area Planning.

Mr. Ertel stated the law is getting ready to change on the area planning board. There should be 11 on the board not 12. The Commissioners stated they will ask around for someone to sit on the board.
