Pledge of Allegiance

Roll Call

Present: Commissioner Mark Horstman, Commissioner Roger Gullion, Commissioner Jeff Volz, Attorney, John Ertel, Auditor, Amy Copeland.

General Public - Mike Cord

Mr. Cord wanted to know about bridge 9 on Cave Hill Road. The Commissioners stated that they are going to do their best to keep the bridge open as long as they can. It is \$12,000,000.00 to replace the bridge.

Coroner — Jason Bailey & Jason Smith

Mr. Smith was in to see if the Maintenance truck could be transferred to the Coroner's office. They would put a camper shell on the truck. The van the coroner's office has you are in the vehicle with the deceased person.

Health Dept — Jason Smith

Mr. Smith stated that the Health Officer job has been posted. They have had one person apply. Commissioner Horstman stated that something needs to be done with the appointment. The Commissioners asked for it to be advertised more.

Highway — Jason Edwards

Mr. Edwards is thinking that they may put a steal bridge in beside bridge 9. He is getting the prices for that. This will be done by the end of the year 2028.

Mr. Edwards stated the Highway Garage wants to do permits for driveway culverts and attach a fee to it. The fee would be \$25.00.

911 — Will Sunderman

Mr. Sunderman told the Commissioners that the Highway Garage FCC license expired in January, he is working on getting it renewed.

Mr. Suderman stated that he has been doing QA in 911 and has been going really well.
