# Ripley County Commissioners Meeting March 17, 2025

# **Pledge of Allegiance**

#### Roll Call

**Present:** Commissioners Mark Horstman, Roger Gullion, Jeff Volz, John Ertel, Attorney, Amy Copeland, Auditor

# Sheriff — Lee Davidson, Chief Deputy

Mr. Davidson talked to the Commissioners about the camera upgrade. He stated that the whole control system needs to be updated. The quote to fix the control system and the cameras is \$339,000.00. Commissioner Horstman asked Mr. Davidson about the unmarked Sheriff Department cars. He stated that there are 2 of them, one for the matron and one for the jail commander.

## **Maintenance** — Craig Herbert

Mr. Herbert talked to the Commissioners about the walls of the showers at the jail. The Commissioners stated to get a quote to fix the shower walls with stainless steel walls.

Mr. Herbert has Arbor Management quote, for the courthouse and the annex trees in the amount of \$8,850.00 and Adams Tree quote in the amount of \$6,000.00.

Mr. Herbert talked to Dunlap about the bathroom in the Probation Department. The price on that bathroom is \$4,987.00.

**Motion:** Commissioner Volz made the motion to approve the renovation of the Probation Department bathroom, **Action:** Approve, **Moved by** Jeff Volz, **Seconded by** Roger Gullion. Motion passed unanimously. Mr. Herbert brought in an unsolicited quote from Patterson Nursery for fertilizing and weed control, \$165.00 an application/\$660.00yr for the courthouse and the annex for \$125.00 an application/\$500.00yr. The Commissioners have stated they are going to hold until the courthouse project is done.

Mr. Herbert asked if he could extend his vacation days. He has about 7 days left and doesn't have time to take them.

**Motion:** Commissioner Volz made the motion to approve Mr. Herbert to hold over his 7 days of vacation until the end of September, **Action:** Approve, **Moved by** Jeff Volz, **Seconded by** Roger Gullion. Motion passed unanimously.

Mr. Herbert brought in a quote from Cintas for a 5 year sprinkler inspection. The quote is for \$2,490.00.

## **EMS** — Alex Poole

Ms. Poole brought in a purchase order for a new ambulance for \$275,000.00.

Ms. Brinson brought in a complaint on 8193 S SR 129, Cross Plains, IN 47017, they are complaining about the neighbors pumping water on the state highway. This is causing a hazard for the public. The Commissioner's Attorney told Ms. Brinson that she should contact the State Representative and the Attorney General's Office.

# Veregy - Art Noel

Mr. Noel came in to give an update on the Courthouse and Jail renovation.

The Commissioners talked about the clock tower renovation and it leaking. The quote is for \$636,406.00 to get the clock tower fixed by Kramer and Sons, Inc.

# Main Street Versailles - Holly Wehr

Ms. Wehr was in to talk about the trees at the Annex and Courthouse. The Commissioners wanted to make sure that the Town and the residents knew exactly what was going on.

#### Area & Planning-Tad Brinson

#### Ripley County C.A.R.E. Inc — Geneen Ostendorf
