# Ripley County Commissioners Meeting May 10, 2024

## Pledge of Allegiance

#### Roll Call

**Present:** Mark Horstman, President, Kendall Hankins, Chris Schmaltz, Amy Copeland, Auditor and John Ertel, Attorney.

### Maintenance - Craig Herbert

Mr. Herbert stated that GenSet Tech, Inc came in and done all the services on the generator. This will be the last time that the generator will be serviced by the county at the WRBI station.

**Motion:** Commissioner Schmaltz made the motion to stop all maintenance on the generator at the WRBI tower. A letter will be sent to the WRBI station., **Action:** Approve, **Moved by** Chris Schmaltz, **Seconded by** Kendall Hankins. Motion passed unanimously.

**Motion:** Commissioner Hankins made the motion to approve the GenSet Tech, Inc new contract for all the generators, **Action:** Approve, **Moved by** Kendall Hankins, **Seconded by** Chris Schmaltz. Motion passed unanimously.

Mr. Herbert stated that the State Fire Marshall was in on Wednesday. The Sheriff Department got wrote up for fire extinguisher and lights. The Sheriff & Mr. Herbert discussed doing the inspection during business hours. Mr. Herbert will do the inspections on the extinguisher and lights before business hours start.

#### Sheriff - Rob Bradley & Chief Deputy Lee Davidson

Mr. Davidson stated that the Sheriff's Department received \$29,621.70 from the insurance for the totaled vehicle.

**Motion:** Commissioner Schmaltz made the motion to accept the settlement of \$29,621.70 for the totaled 2015 charger, **Action:** Approve, **Moved by** Chris Schmaltz, **Seconded by** Kendall Hankins. Motion passed unanimously.

The Sheriff is now going to need another new vehicle since the one is totaled. The Commissioners are going to transfer \$35,000.00 from Riverboat/Building to Riverboat/motor vehicle.

Chief Deputy Davidson stated they have met with Enterprise Fleet for their need of vehicles. The Sheriff is going to meet with Enterprise Fleet again to discuss further.

#### Highway - Jason Edwards

Mr. Edwards stated that the catch basins were breaking in Friendship. The highway garage is going to fix these.

Mr. Edwards stated he is losing heat through the roof. They are going to put metal on the ceiling of the highway garage to keep the heat In the building. The Commissioners told Mr. Edwards to get some quotes for the work on the highway garage ceiling.

#### CCMG - Bid Opening

We received bids from Paul Rohe, Dave O'Mara, & All star paving. Attorney Ertel went over the bids all of the companies had all the paperwork they needed.

Mr. Huffman stated they are having trouble with one of their chase vehicles. It is a Ford and Ford is going to pay \$5,000.00 for a new motor to be put in due to the vehicle having so many problems.
