Councilman R. Decker made a proposal to the Council to offer a reimbursable grant to the Ripley County Volunteer Fire Departments (VFD ) (excluding Batesville) in the amount of \$10,000.00, per year. VFD's would have to apply for it and it would have stipulations. For example, to be used for safety gear, not training, etc. *Councilman Ehlers requested that this be added to the upcoming Budget Meeting.*

Council discussed repairs to the Courthouse Clock. Estimated cost ~\$60,000.00. It was suggested to apply for grants in order to cover cost of this project, not tax dollars. *Individuals offered to look into grant options like RCCF, REMC and Tyson Fund.*

Councilman A. Decker suggested discussion regarding the 2026 raises. *Councilman Ehlers requested an Executive Meeting be scheduled for August 4, 2025 in order to discuss the 2026 Raises.*
