Prosecutor - Rick Hertel

911 – Leah Hildebrand & Jonathon Phillips

Mr. Phillips got up and spoke to the Council about a raise for the 911 employees. He stated they are losing employees to the Indiana State Police Post and the Batesville Dispatch. The 911 employees are wanting a 20% raise for the director, 25% raise for the assistant director and a 20% raise for all other dispatchers. They also stated that if they cannot do the percentage that they would be willing to accept a four thousand dollar raise across the board. Ms. Hildebrand got up and spoke to the council about how important the 911 dispatcher job is. She stated these employees deserve this raise. The Council stated they would discuss what is being presented.

Sheriff - Rob Bradley & Chief Deputy - Lee Davidson

Mr. Bradley stated that he was in to talk about giving the Sheriff's Department a raise. Mr. Bradley stated they are losing employees to the Indiana State Police Post and the Batesville Police Department. Mr. Davidson stated he would have the request in to the Council by the end of the week.

The Ripley County Council scheduled a special public meeting for January 24, 2023 to discuss budgets and raise proposals.

Mr. Anderson was in to discuss the start of the courthouse renovation. The estimated cost of this renovation is \$3,058,981.00.
