## Maintenance - Craig Herbert

Mr. Herbert stated that Tyler Bond will fix the shingles and ridge cap at the courthouse for \$150.00. Commissioners approved for Tyler Bond to fix the roof.

Mr. Herbert stated that the AC unit went out at the jail. The quote from Dunlap is for \$7,964.00 for a new unit this does include a new furnace. The Commissioners want it paid out of the Cum Cap funds.

## **Economic Development - Gary Norman**

Mr. Norman brought in an Inter-local agreement from 2022 & 2023.

#### Safe Haven Baby Box - Randy Frye; Karen Erlewein & Mary Beth Boone

Ms. Erlewein would like to dedicate the baby box in memorial of her son that was killed in a motorcycle accident recently. Ms. Boone mentioned they have done plaques in honor of someone or benches. Ms. Erlewein will raise funds to have a bench made to be located at the Versailles location. Commissioners have approved to have a bench. John Ertel had concerns/questions with regards to the language in the contract for the baby boxes. Save Haven Baby Box funding is \$20,000 combined in donations for both Versailles & Milan locations. Sunman Town board approved to have a baby box in the town that will be located in a private building. They received a donation of \$11,000.

#### **Highway - Ray Toops**

Mr. Toops stated they have completed 26 miles of chip-n-seal.

Mr. Toops also stated that the old Gradall is gone and payment accepted.

Mr. Toops stated the CCMG application process has been opened on July 1, 2022.

Mr. Toops would like to apply for the grant again. The grant application process ends 8/31/22. The Commissioners do not think they should put in for the grant, but they should use the money left from matching portion to chip and seal.

### **General Public - Duane Swingle**

Mr. Swingle was in regarding County Road 600 East. The Commissioners are going to chip and seal to the driveway of the Swingle's. The Commissioners will then put a sign up that states travel at your own risk.

#### **Bid Openings**

The Commissioners received 2 highway bids - one from Rohe and one from Dave O'Mara.

Dave O'Mara gave a total project cost of \$769,250.00.

Rohe did not have a "total" cost for the project.
