Ripley County 4H Junior Leaders, Macey Young and Riley Mitchell, accompanied by their Junior Leader Advisor, Monica Hansen, gave a presentation on what they learned at their Leadership Training at DePauw University and gifted the Council with homemade cookies thanking them for their support.

New Business:

Jason Edwards, Highway Superintendent, (handout- Performance Evaluation) - Mr. Edwards stated that he would like to base his employees' pay on performance evaluations, starting in 2024. Commissioner R. Decker explained that the Council has been discussing and plan to implement a matrix system for payroll in 2025 and that all departments will be following this same method and changes will not be made until then.

Ben Sieverding, Versailles Fire Chief, stated that he wanted to check back in with the Council to make sure that they had everything they needed from the Ripley County Fire Chiefs for the 2024 Budget. R. Decker said yes. Chief Sieverding was accompanied with multiple area fire fighters.

Lee Davidson, Chief Deputy, and Ruth Ann Adkinson, Matron, were in attendance to answer any questions regarding the Commissary Report. Council had no questions.

Councilman President, Peggy Ehlers arrived.

Old Business:

Rick Anderson, Veregy accompanied by Mark Frost & Zack Simms. (handout — Ripley County Guaranteed Energy Savings Project) Mr. Anderson expressed his apologies and explained the reasoning for the cost increase of the project. HVAC materials and labor seem to be the main factor of this increase though other elements, as well, have affected the costs. Councilman Wiedemen, stated he believes the HVAC cost increase is legit. Councilman Wiedeman proposed holding off on the window replacement and bathrooms. Council wants to avoid bonds or loans. Mr. Anderson shared that there are financing options. Councilman Tebbing suggested Veregy relook over their numbers and come back at the August meeting with findings. Councilmen R. Decker suggested Councilman Ehlers select a committee of 3 to work with the Auditor regarding budgeting options. Peg asked for volunteers. Stan Wiedeman, David Tebbing and Andrew Decker were selected. Peg asked that they get with Amy prior to the August County Council Meeting and be prepared to give Veregy an answer. Councilman A. Decker asked Veregy if they can see about doing the project at a million less. Motion: Councilman President made a motion to table further discussion of the Ripley County Guaranteed Energy Savings Project until the August 21, 2023 County Council Meeting. Action: Approved, Moved by Councilman Tebbing, Seconded by Councilman Wiedeman. Motion passed 7 yes.

Additional:

John Ertel, County Attorney, spoke on the Public Safety Tax. (Handout – Ordinance Adopting/Modifying Local Income Tax Rates Ripley County, Indiana) Mr. Ertel stated that there is a needed correction on page one, replace 0.2% with 0% under Existing LIT Rate for Correctional of Rehabilitation Facilities. Mr. Ertel went over the handout and told Council he has a few more questions, that he wants to make sure they are doing this correctly.

Motion: Councilman R. Decker made the motion to adjourn, **Action:** Approved, **Moved by** Andrew Decker, **Seconded by** David Tebbing. Motion passed 7 yes.
