The Ripley County Council talked about the runs the Ripley County EMS have been taking in Dearborn County and if there is a way to charge Dearborn County for those runs. Mr. Huffman stated that all of the equipment is in good shape for the year 2022, but anything can happen. The Ripley County Council asked the Auditor and Mr. Huffman to look into an EMS tax or other options that other counties in Indiana do. This matter is tabled until the next meeting on July 19, 2021.
