Pledge of Allegiance

Roll Call

Present: Mark Horstman, President, Chris Schmaltz, Amy Copeland, Auditor. John Ertel, County Attorney. Kendall Hankins was absent.

Maintenance - Craig Herbert

Mr. Herbert brought in 2 quotes for the cleaning of the floors in the Annex building. Watkins Hydra Steam for the amount of \$3,986.00 and Magna-Dry for \$9,188.84. Watkins Hydra Steam is also going to do the Veteran's Office for free.

Motion: Commissioner Schmaltz made the motion to have Watkins do the cleaning of the floors in the Annex building, **Action:** Approve, **Moved by** Chris Schmaltz, **Seconded by** Mark Horstman. Motion passed 2 yes 1 absent.

Mr. Herbert also stated he is going to need 6 push buttons for the sinks and toilets. They are \$700.00 per unit to fix and that is the cheapest Mr. Herbert can find.

Mr. Herbert also spoke about a leak in the 911 office. He stated he cannot fix it until it rains hard enough to see where the leak is coming from.

911 - Leah Hildebrand

Ms. Hildebrand brought in the Antenna Site Lease Agreement. Attorney Mr. Ertel stated that we need to get confirmation from Mr. Samples on the insurance portion of the lease, then the lease could be signed.

Ms. Hildebrand also wanted to know where she should pay for the surveys at. The Commissioners stated the ARP money.

The bid has been advertised in the Versailles Republican and the Greensburg Daily News. The bids are due on September 30, 2022.

Mr. Ertel stated we also need to work on the easement for the towers at Versailles Town Property and the Napoleon Volunteer Fire Department.

EMA - Randy Miller

Mr. Miller talked about a weather radio on a tower that would be owned by Ripley County for 911. This is a work in progress.

Mr. Miller stated they have looked at 4 vendors for mass notifications. Mr. Miller stated with everyone's' input they have decided on Hyper-Reach. Hyper-Reach is \$6,900.00 a year.

Mr. Miller stated that they have made an incident commander trailer with the Health Department trailer they had. It is working out great for Ripley County.
